QUALIFICATIONS:

- High School diploma or GED.
- Three or more years of experience in facility maintenance or closely related field.
- Working knowledge of some combination of several of the following; mechanical, electrical and plumbing systems, carpentry, grounds keeping, HVAC and other maintenance related areas. Certifications are not required, although they can be useful as a means of demonstrating one's ability to handle the job effectively.
- Can perform routine maintenance around the building such as fixing structural damage.
- Able to identify and fix potential safety hazards to avoid injuries.
- Ability to paint internal and external areas of building as required.
- Pool and boiler experience a plus.
- Ability and current license to drive with record that meets YMCA standards.
- Familiarity with personal computer helpful.
- Interpersonal skills to interact with members or staff of the YMCA in way that is consistent with Y values and successfully builds teamwork.
- Attention to detail to ensure that all jobs are completed in an exemplary manner and any potential hazards or warning sign of problems are addressed in a timely and thorough manner.
